Vaccine information

Please contact your physician or one of our primary care providers with questions related to COVID-19 vaccine options and for further guidance.

• COVID-19 vaccines are now available to anyone age 12 and older (only Pfizer for those under 18 years) and Pfizer, Moderna, and Johnson & Johnson for anyone 18 years of age and older. Contact each clinic directly regarding which vaccine is available and schedule an appointment as vaccine type and availability will vary.

• Valley View is following the FDA and CDC guidelines/ recommendations for third COVID-19 vaccine/boosters. Currently, the CDC recommends a third dose 28 days after second dose of both Moderna and Pfizer for immunocompromised individuals **and** a booster six months from second dose for only Pfizer. Boosters are recommended for:

- individuals 65 years of age and older;
- individuals 18 through 64 years of age at high risk of severe COVID-19; and
- individuals 18 through 64 years of age whose frequent institutional or occupational exposure to SARS-CoV-2 puts them at high risk of serious complications of COVID-19 including severe COVID-19.
