When the standard cardiac workup didn't reveal an answer to an elderly man's chest pain, Dr. Simpson and Dr. Fauchet continued to search, found the correct cause and linked our patient to life-saving treatment. It feels good to have great teammates—thank you!”

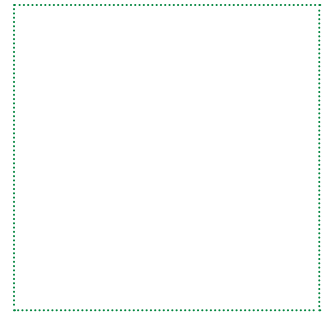
