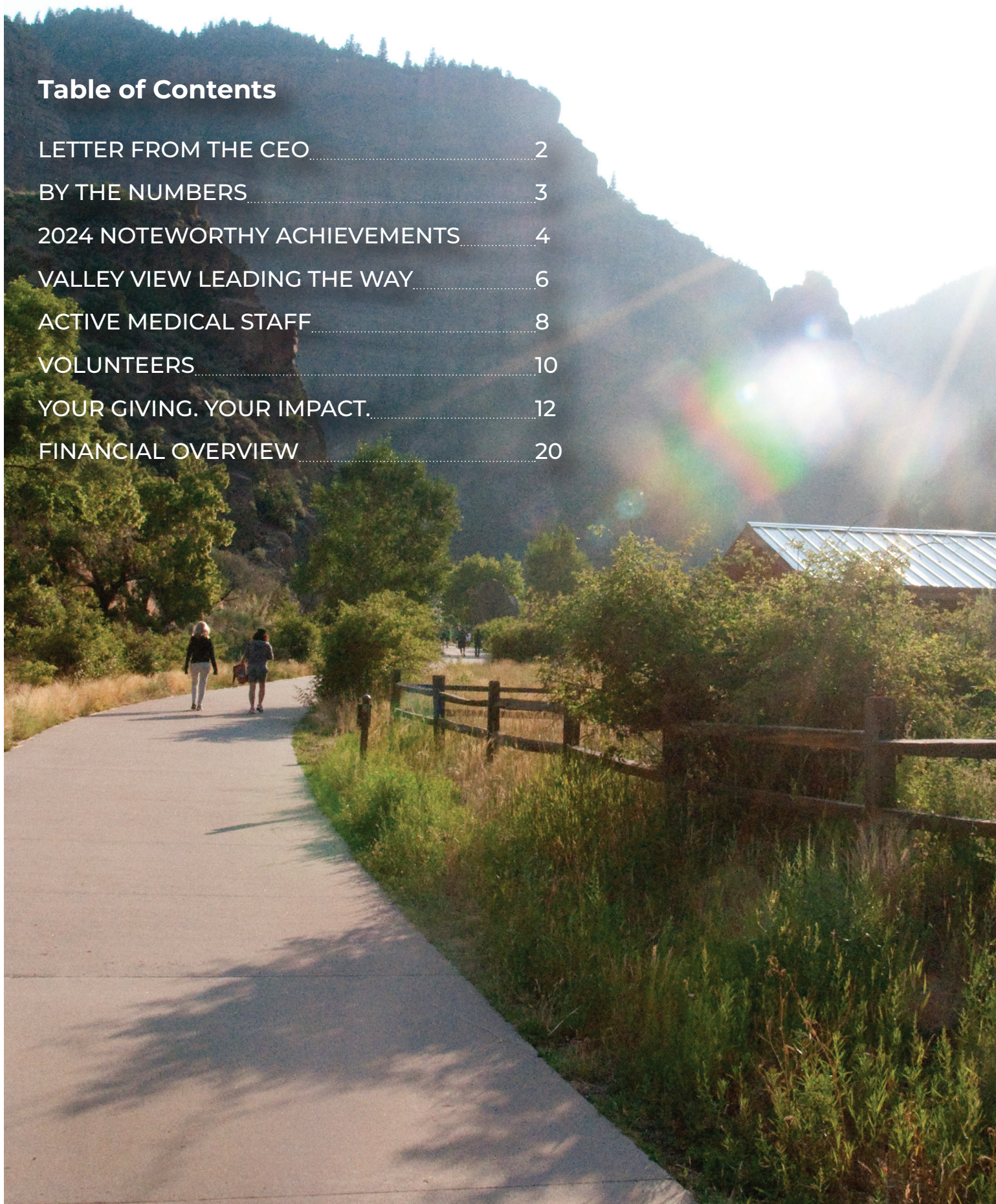

A shining achievement of 2024 is our Five-Star Overall Hospital Quality Rating from the Centers for Medicare and Medicaid Services (CMS). Of 4,665 hospitals rated nationwide, Valley View was among only 381 hospitals and 17 in Colorado to receive five stars, putting our hospital in the top eight percent in the nation. I am so proud of this national achievement and grateful for the dedicated work of our team to realize it.

While this CMS five-star rating is cause for celebration, we continue to work every day to care for our patients. Our investment in new services, new providers and new facilities support and improve the health of our community. With the support of this vibrant and remarkable community, we know many more recognitions will follow.

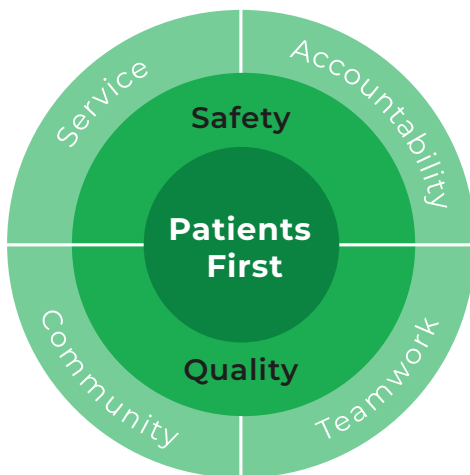

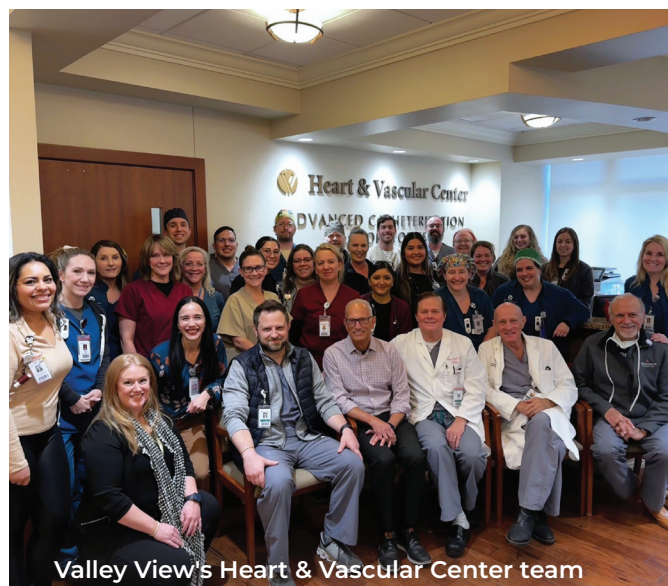

Five-Star Overall Hospital Quality Rating from the Centers for Medicare and Medicaid Services

Valley View received a coveted Five-Star Rating for Overall Hospital Quality from the Centers for Medicare and Medicaid Services (CMS). Valley View was one of only 17 hospitals in Colorado to receive this prestigious designation. The 2024 ratings for hospitals nationwide are based on their performance across 46 hospital quality measures, that are divided into five quality categories including safety of care, mortality, patient experience, readmission rates and timely and effective care. The award highlighted Valley View's patient-centric approach to health care, guided by values such as safety, quality and service to the community. Valley View is committed to keeping care local as the region's independent health care leader.

Top 10 hospital in the U.S. for lowest mortality rates among heart attack patients

Valley View Hospital had one of the lowest 30-day mortality rates for heart attack patients in the U.S. between July 1, 2020 and June 30, 2023, according to Centers for Medicare and Medicaid Services (CMS). CMS calculates mortality rates based on deaths within 30 days of a patient being admitted to the hospital for heart attack, heart failure, pneumonia, chronic obstructive pulmonary disease, stroke and coronary artery bypass grafts. This rating demonstrates Valley View's excellence and commitment to delivering the most advanced, high-quality care.

Caring for those in need

In 2024, Valley View provided nearly \$29 million in charity care, a nearly \$10 million increase from 2023. This is a powerful demonstration of Valley View's commitment to caring for those in need in our community.

Upgrading imaging technology

Imaging plays a pivotal role in the complete care approach at Valley View, offering critical support to various medical departments including oncology, orthopedics and cardiology. In 2024, Valley View made significant updates to its cache of equipment and software. The markedly advanced GE Revolution Apex Machine, a 256-slice CT scanner and the introduction of MRI upgrades featuring AirReconDL software and artificial intelligence (AI) technology ensure patients benefit from the latest in imaging innovation, setting the standard for care in the region.



Expansion of the **Critical Care Unit**

The Critical Care Unit (CCU) at Valley View Hospital offers the highest level of intensive care among hospitals between Grand Junction and Denver. From cardiology to trauma to pediatric patients, this unit is essential to the care of our patients and the health of our community. With increasing patient volumes and rising complexity of patient needs, Valley View completed three additional rooms in the CCU in 2024.

“Pediatric Ready”

Valley View was officially recognized as “pediatric ready” by the Colorado Pediatric Preparedness for the Emergency Room (COPPER) Program, marking the first Level III Trauma Center in Colorado to be COPPER verified. Being pediatric-ready means having the specific skills, equipment, protocols and other components necessary for high-quality emergency care of children. As a Level III Trauma Center, Valley View provides 24-hour coverage by emergency medicine physicians, general surgeons and anesthesiologists. This prestigious designation highlights Valley View’s commitment to providing exceptional emergency care tailored specifically to the needs of pediatric patients.

2024 **Women’s Choice Award**

Once again, Valley View was recognized as one of America’s Best Hospitals by the Women’s Choice Award, a trusted referral source for the best in health care. Valley View received recognition in the following categories in 2024:

- Best Hospitals for Orthopedics
- Best Small Hospitals – Comprehensive Care (25–100 beds)
- Best Hospitals for Obstetrics
- Best Hospitals for Heart Care
- Best Hospitals for Minimally Invasive Surgery

The Women’s Choice Award only awards the top 10% of hospitals nationwide. The award signifies that Valley View is in the top 1% for best hospitals in orthopedics, the top 2% for best small hospitals in comprehensive care (25–100 beds), the top 4% for obstetrics and heart care and the top 6% for minimally invasive surgeries.

Valley View Leading the Way

Collaborations bring **care closer to home**

The rural nature of our community can be challenging for patients who need health care. Valley View works collaboratively with providers across our region to bring important services closer to home. For example, members of Valley View's Calaway•Young Cancer Center travel to Aspen Valley Hospital, Grand River Health in Rifle and Memorial Regional Health in Craig to provide cancer care locally. The Heart and Vascular team travels to hospitals in Craig, Meeker and Rangley to provide cardiovascular services. These collaborations help even more community members get the care they need.

Partnering to support **patients' whole health**

Health extends beyond the walls of Valley View, and nonmedical factors, known as social determinants of health, influence an individual's overall health. These factors include socioeconomic status, education, housing and food security. For example, if an individual does not have access to nutritious food, they can be at an increased risk of chronic disease.

Valley View strives to address these needs through partnerships with a wide range of community organizations and agencies. Across the Valley View network of care, this starts with a screening in which all patients are assessed for social determinants of health. Staff then work to make referrals and connections. For example, the organization Great Expectations provides guidance and support to new parents of Valley View's Family Birthplace. A Way Out helps our patients find substance use disorder treatment. Our county public health departments' Women, Infants, Children (WIC) programs provide wholesome food for pregnant women and children three and under.

Through collaborations with local nonprofits, public health agencies, schools and more, Valley View patients are connected with resources and services to support their whole health.

Connecting with the community

In addition to delivering around-the-clock care and essential health care services, Valley View works to connect with the community broadly and further uplift the well-being of the community.

In 2024, ValleyOrtho's certified athletic trainers provided nearly 6,000 complimentary injury assessments and treatments to youth and adult athletes from across our community. These dedicated professionals support every high school in the Roaring Fork School District plus events such as Aspen Ruggerfest, Roaring Fork Lacrosse Club tournaments and Colorado Rocky Mountain School soccer games.

Valley View believes that when individuals and communities are empowered with information to make informed choices they can take more proactive steps toward better health. Our expert physicians

and clinical team members led free educational talks on topics ranging from heart health to prostate health and screening through the virtual Valley View University. Further, at its annual Kids Safety Fair, Valley View and other community partners helped both children and their families learn about bicycle, water and fire safety. Free bicycle helmets, made possible by the Valley View Foundation, ensured that kids can practice the safety lessons they learned.

Additionally, in 2024, Valley View partnered with more than 35 community nonprofit organizations, clubs and events. From the Parkinson Association of the Rockies to the Glenwood Springs Chamber of Commerce, Valley View is proud to support these remarkable entities as their work ensures our communities remain strong.

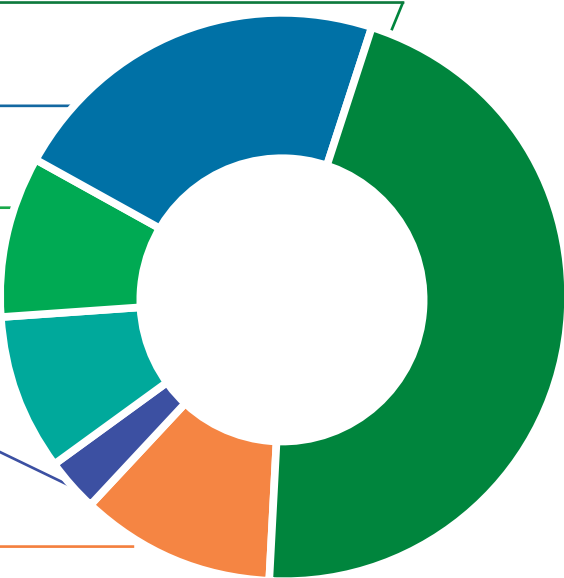
