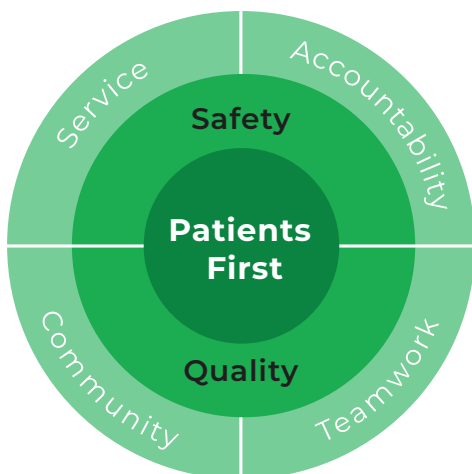

Second Five-Star Overall Hospital Quality Rating from the Centers for Medicare & Medicaid Services

Valley View earned its second Five-Star Overall Hospital Quality Rating from the Centers for Medicare & Medicaid Services (CMS) in 2025, reaffirming its position among the nation's top-performing hospitals. The CMS rating evaluates hospitals across 45 quality measures grouped into five key categories: safety of care, mortality, patient experience, readmission rates and timely and effective care. *Achieving a Five-Star designation places Valley View in an elite group—one of only 12 hospitals in Colorado and just 290 nationwide to receive this recognition.* This distinction reflects the hospital's ongoing commitment to excellence, continuous improvement and delivering exceptional care to every patient it serves.

Caring for those in need

Valley View's investment in charity care underscores its longstanding commitment to serving all members of the community. In 2025, Valley View provided \$29.3 million in charity care. By providing financial assistance to patients who are unable to afford necessary medical services, Valley View ensures that care remains accessible, compassionate and equitable. This support helps individuals navigate unexpected health challenges without the added burden of financial strain. Charity care remains a vital component of Valley View's role as a trusted community health care partner.

New physical therapy clinic in New Castle

A new physical therapy clinic brings individualized, one-on-one treatment to the New Castle community, including pelvic floor therapy, neurologic rehabilitation, vestibular therapy and concussion management. Located above the New Castle Coffee Shop and staffed by experienced therapists, this new location reflects Valley View's commitment to providing care where patients live and work.

New Community Health Needs Assessment

Valley View conducts a Community Health Needs Assessment (CHNA) every three years to better understand the most pressing health challenges facing local residents. The 2024 assessment guided the development of a new 2025 action plan focused on three priority areas: total cost of care, access and availability of services, and social determinants of health that influence overall well-being. This plan strengthens Valley View's ability to address affordability, expand essential services and support factors such as housing, transportation and food security. By aligning its efforts with community-identified needs, Valley View ensures its work remains responsive, equitable and impactful for the region.

Advancing digestive health across the region

Valley View continues to strengthen access to high-quality digestive health care throughout the Western Slope. The Valley View Gastroenterology Center provides comprehensive evaluation, diagnosis and treatment for a wide range of gastrointestinal conditions, supported by an expert team committed to delivering compassionate, personalized care.

The gastroenterology team offers deep expertise in conditions such as GERD, gallstones, peptic ulcer disease, Crohn's disease, hepatitis and other disorders of the digestive system. With a state-of-the-art endoscopy suite, patients receive care in a private, comfortable environment for procedures including EGD, colonoscopy, flexible sigmoidoscopy and ERCP—critical tools for detecting disease early and improving long-term health. Valley View Hospital patients also benefit from 24/7 gastroenterology coverage, ensuring that urgent gastrointestinal needs are met promptly and safely at any time of day.

In 2025, Valley View made significant strides in expanding access to advanced digestive health services. Improved scheduling availability for appointments and procedures was a major focus. The Gastroenterology Center broadened its geographic reach by offering clinics in Eagle, Silt and Willits. 2025 also marked the beginning of offering procedures at the Valley View Surgery Center in Basalt, making care more convenient and accessible for patients across the Roaring Fork Valley.

A major milestone was the addition of Bob Etemad, MD, a multi-board-certified advanced interventional endoscopist and gastroenterologist. Dr. Etemad brings extensive experience from leading institutions including Main Line Health, Jefferson University Hospital and Ochsner Clinic Foundation. His philosophy emphasizes that every patient deserves access to excellent, timely care.

At Valley View, Dr. Etemad performs complex interventional endoscopy procedures that often

eliminate the need for surgical incisions, addressing conditions such as pancreatic and bile duct disease, gastrointestinal cancers and Barrett's Esophagus. He is also a dedicated advocate for cancer prevention and early detection, emphasizing healthy nutrition, awareness of family history and appropriate screening.

Dr. Etemad joins a strong and growing team that includes Dr. Eric Gochanour, Dr. Michael Baird, two physician assistants and two nurse practitioners. Together, this team provides comprehensive digestive health services and works closely with patients to develop individualized care plans. They are quickly being recognized as the region's gastrointestinal referral center, caring for patients across the mountains and Western Slope thanks to their training and advanced procedures.

As Valley View looks ahead, it remains committed to expanding access, elevating quality and ensuring that every patient receives exceptional digestive health care close to home.

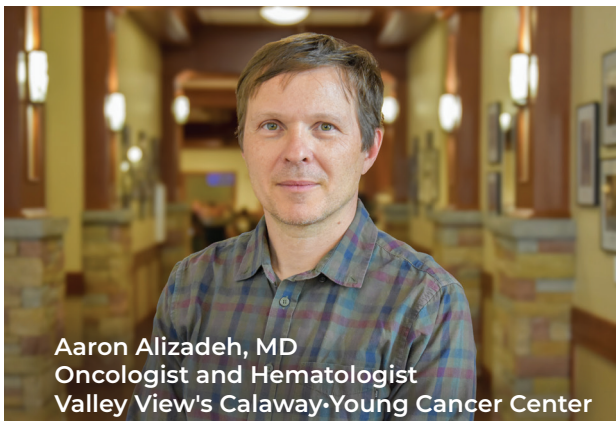

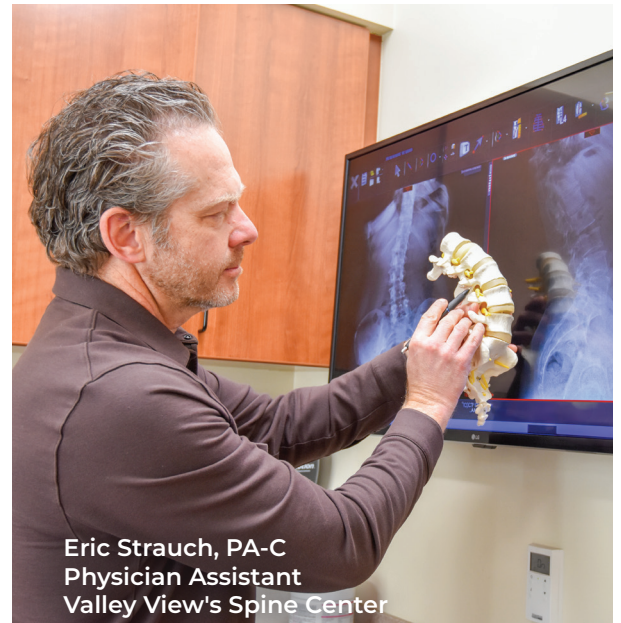

Contributions allowed Valley View to acquire advanced medical technology and state-of-the-art equipment, ensuring patients receive the most cutting-edge treatments available. Examples include a portable life support system to provide advanced therapy for critically ill cardiac patients, specialized monitors to serve the youngest of patients in the Neonatal Intensive Care Unit (NICU), a skin-therapy device offering a noninvasive treatment option for skin cancers without scarring, and more.
