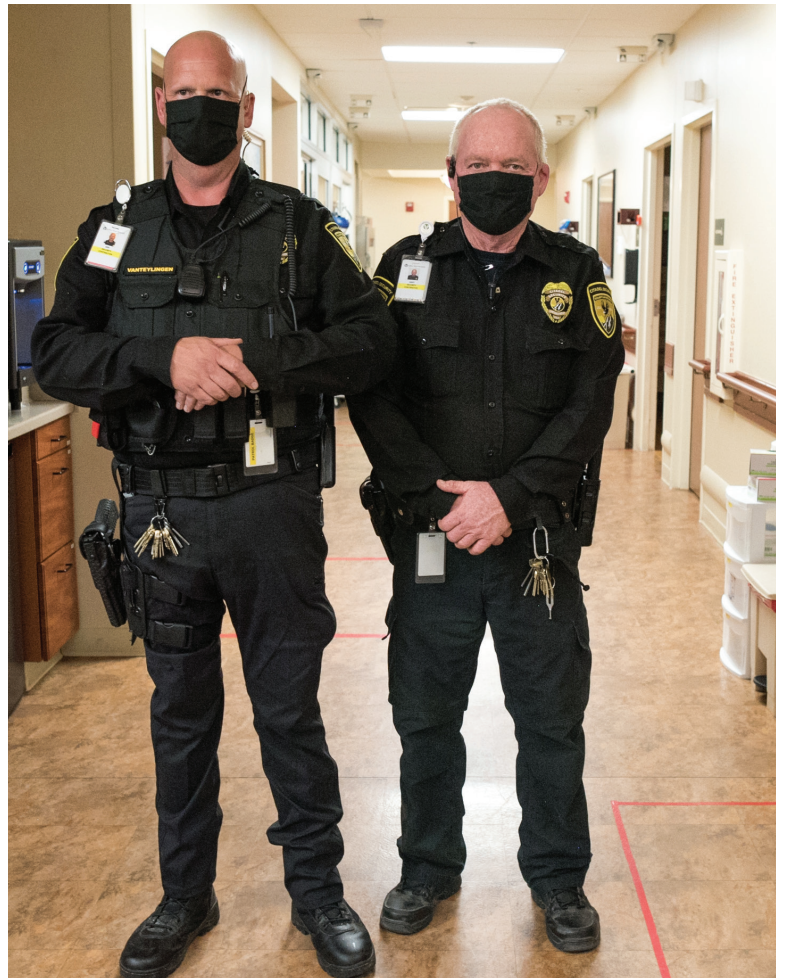

For many of us, 2020 was an exceptionally challenging year. The COVID-19 pandemic brought unprecedented changes to various aspects of our lives. Yet no matter how impossibly challenging the year seemed, Valley View persevered to ensure the exceptional care of our patients. We stepped outside the immediate care of our patients to share our knowledge and expertise of the virus. From participating in public forums to fielding questions from business owners about how best to protect their staff, our response to the COVID-19 pandemic evolved to serve the entire community.

As of the publication of this report, Valley View is leading our community in administering COVID-19 vaccines. Thousands of our community members, many among the most vulnerable to COVID-19, have been vaccinated at no cost. The opening of the new Silt Family Practice demonstrated our continued investment in primary care. This new practice, along with Eagle Valley Family Practice, Internal Medicine, Roaring Fork Family Practice and Pediatric Partners, is the foundation of good health and preventing disease.

Valley View continues its commitment to you, your friends and family through world-class specialty care, close to home. In 2020, we were one of only 124 hospitals to be honored for our treatment of heart attack patients. This is a tremendous accomplishment that I hope our community may take pride in as well. We also made incredible advancements to make sure that our community can receive trusted orthopedics care. Now known as ValleyOrtho, we are proud to offer our community a new location in Aspen and new fellowship-trained orthopedic surgeons to care for patients.

To not only respond to a global pandemic but also achieve so many other accomplishments is a powerful reflection of the tenacity and resilience of our Valley View team. To our providers, staff, donors and volunteers: thank you for your care and expertise. Together, I know that we will continue to persevere through the COVID-19 pandemic and support a bright future for healthcare in our community.

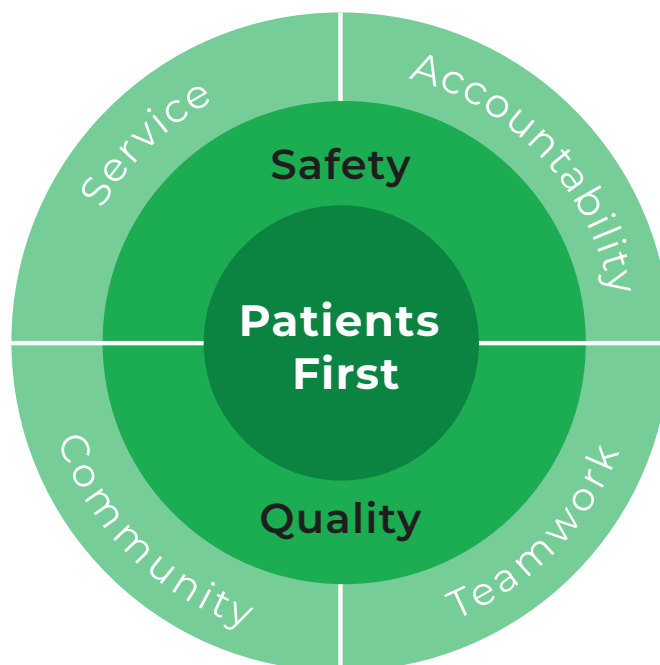

RESPONDING TO THE COVID-19 GLOBAL PANDEMIC LOCALLY

Early in the year, Valley View began to prepare for the presence of the novel COVID-19 virus in the community and care for those patients affected by the virus. On March 6, 2020, the organization's Incident Command team started meeting on a daily basis. The team represented a huge cross-section of Valley View: inpatient nurses, hospitalists, materials management staff, emergency department team members, family practice providers, pharmacists, employee health professionals, and executive leaders. The team began to organize and coordinate every possible response element needed to care for COVID-19 patients. Valley View quickly established and executed 146 objectives to respond to the pandemic. In a matter of weeks, Valley View transformed itself to lead the community in caring for those with COVID-19.

This level of teamwork, expertise and dedication was vital as community members in Valley View’s service area were diagnosed with the virus. For those with COVID-19 who required medical care, Valley View’s physician practices were ready with new VirtualCare telehealth appointments. New treatment areas opened, both indoors and outdoors, to care for those sick with COVID-19 across Valley View’s network of care. For example, at Valley View Hospital, a respiratory tent was set up outside of the main hospital building to triage patients and perform vital COVID-19 diagnostic testing. The emergency department established two distinct areas to care for those with COVID-19 symptoms and those without. In addition, a new COVID-19 Community Hotline opened to field questions and concerns from the community.

For COVID-19 patients requiring hospitalization, new spaces and rooms were constructed to support safe airflow and effective patient care. Four new negative pressure rooms and an antechamber were constructed in the hospital’s critical care unit. In acute care, space was transformed to ensure appropriate care spaces

for COVID-19 patients. The hospital developed overflow plans and coordinated with other community organizations to create alternative care sites, if needed.

The ingenuity of Valley View nurses launched a sewing center for staff from other areas to help

produce protective masks and gowns. This work was featured on national news as people across the country followed the shortage of these protective supplies for medical personnel. Incident Command addressed multiple, ever-changing issues related to personal protective equipment (PPE), COVID-19 diagnostic testing and the medical treatment of COVID-19 patients.

Time and again, doctors, nurses and staff collaborated to understand challenges and work to address them.

The generosity of the community helped to fuel this work, literally, with donations of many meals. Notes from community members thanking frontline staff were shared and posted across the organization. Dental practices and tattoo shops donated their masks and gloves to help protect the nurses and doctors at Valley View. Financial gifts to the Valley View Foundation also supported the

numerous, additional expenses incurred due to Valley View's response to the virus.

In addition to caring for COVID-19 patients, Valley View also participated in forums and collaborated with the media. From Brett Hesse, MD, speaking with the El Montanes newspaper to David Brooks, MD, being interviewed by Aspen Public Radio, Valley View providers shared crucial information with the community about the virus.

Valley View CEO Brian Murphy, MD, led weekly Facebook updates to make sure the community knew about the hospital's capacity and ability to care for all patients. Valley View also worked to promote critical

behaviors to slow the transmission of the virus: wearing a mask, practicing social distancing and frequent hand washing.

Valley View brought its expertise to support other businesses and key organizations in their response to COVID-19, too. Incident Command team members worked closely with local schools as they put together plans for hybrid and in-person learning. A special Zoom forum was also hosted for area dental professionals to share Valley View's 'lessons-learned,' to help in the care of their patients and protection of their staff from the virus. Many other community business owners and leaders also turned to Valley View for its expertise as they sought to respond to COVID-19 and the various phases of the pandemic.

In mid-December, Valley View assumed a new role within the pandemic: vaccine administrator. Working from state and local public health guidelines, the team at Valley View administered the first COVID-19 vaccines on December 16, 2020. With the understanding that each vaccine administered represented a possible life saved, Valley View's Incident Command team took up the community banner to administer as many vaccines as possible. Despite the challenges of vaccine supply, Valley View led the way in leading multiple vaccine clinics every week to administer thousands of COVID-19 vaccines at no cost. Staff from across Valley View were re-deployed to weekly vaccination clinics to perform this community service. The laughter and smiles from first responders to seniors receiving the vaccine were an incredible affirmation of the work and leadership in which so many at Valley View have contributed.

COVID-19 brought out the best in Valley View – its dedication to the community and to putting patients first. We are grateful to all who have rallied with us.

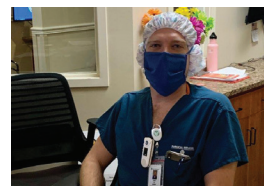
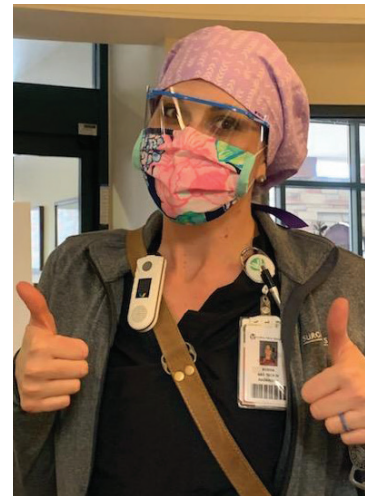

2020 Noteworthy Achievements

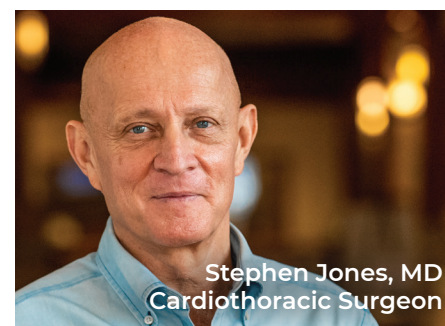
NATIONAL TOP PERFORMER FOR TREATMENT OF HEART ATTACK PATIENTS
Valley View received the American College of Cardiology's NCDR Chest Pain—MI Registry Silver Performance Achievement Award for 2020. Valley View is one of only 124 hospitals nationwide to receive the honor.



The award recognizes the Heart & Vascular Center at Valley View for its commitment and success in implementing a higher standard of care for heart attack patients. It signifies that Valley View has reached an aggressive goal of treating these patients to standard levels of care as outlined by the American College of Cardiology/American Heart Association clinical guidelines and recommendations.

Always working to expand care for patients, The Heart & Vascular Center welcomed Dr. Jones to begin new cardiovascular services at Valley View. CARING FOR THOSE IN NEED IN OUR COMMUNITY

Each year Valley View provides care for patients who are uninsured, underinsured, ineligible for government assistance, or otherwise unable to pay for medically necessary care. In 2020, Valley View provided nearly \$10 million in charity services that equated to \$4.7 million in uncompensated care.

INTRODUCING **VALLEYORTHO**

Formerly Glenwood Orthopedic Center and Foot and Ankle Centers, Valley View introduced ValleyOrtho in 2020. With a blend of medical mastery and community-inspired compassion, this team of board-certified, fellowship-trained specialists launched with a commitment to helping patients become stronger, healthier and physically ready to live an active life again.

In December, ValleyOrtho welcomed trusted, longtime Aspen orthopedic surgeons Tomas Pevny, MD and Mark Purnell, MD to lead a new office in downtown Aspen. Board-certified, fellowship-trained orthopedic hand surgeon Michael Potter, MD, and fellowship-trained joint replacement and revision surgeon Chad Mahan, MD, also joined the ValleyOrtho team.

For decades, Valley View Hospital has cared for the community with world-class surgical capabilities. In 2020, the Hospital constructed an additional, state-of-the-art operating room and sterile processing space. A new surgical waiting room also opened. In addition to new spaces, Valley View began a perioperative surgery clinic, known as PAT. The clinic supports patients as they prepare for their surgery so that they can have a smooth recovery and the best possible outcome. All of these additions affirm Valley View's commitment to ensuring patients benefit from advanced care close to home.

OPENING OF **SILT FAMILY PRACTICE**

In February, Valley View expanded its network of primary care with the opening of Silt Family Practice. As the only family medicine provider in Silt, Silt Family Practice proudly cares for patients of all ages. The practice serves a diverse community with walk-in availability and same-day access.



SAFE SLEEP CHAMPION

Valley View's Family Birthplace leads the nation for its best practices and education on infant safe sleep. The Cribs for Kids National Safe Sleep Hospital Certification program recognized the Family Birthplace at the 'gold' level. From staff training to parent education, these efforts reflect Valley View's commitment to preventing sleep-related infant deaths.

YOUR GIVING. YOUR IMPACT.

The generosity of Valley View Foundation donors impacted and improved patient care across Valley View in 2020. Over 840 donors contributed over \$1.7 million dollars. Support for patients of the Calaway•Young Cancer Center continued to be a priority for the Valley View Foundation. In addition, the Foundation partnered with other donors to advance the care of patients across the Valley View network of care.

Philanthropist Pete Welles collaborated with Valley View Physicians Suresh Khilnani, MD and Frank Laws, MD, to take on sleep apnea. This condition is endemic in high altitude places like the mountains of Colorado and can cause a host of problems ranging from atrial fibrillation (AFib) and pulmonary hypertension to anxiety and memory loss. In consultation with Dr. Khilnani, Pete resolved to help Valley View become the regional authority on sleep apnea, providing a \$400,000 gift to educate, test and treat central and obstructive sleep apnea.

Thanks to an incredible gift from Marlane Miller, Valley View was able

to begin offering new, advanced screening to help identify breast cancer earlier in patients with dense breast tissue. This new screening is thanks to the purchase of an automated breast volume ultrasound (ABUS or ABVS). One clinical study found mammography, when combined with ABUS, found 1.9 more cancers per 1,000 patient images than traditional mammography alone. Thanks to Marlane's gift, Valley View can help find breast cancer earlier.

Gregory Friedman had a transformational patient experience at Valley View while in the care of Urologist Aashish Kabra, MD. In close discussion with Dr. Kabra, Gregory and his wife, Judith saw a way they could help patients, especially those with prostate concerns. Combining Dr. Kabra's medical insight, Gregory and Judith's knowledge of information technology and a major gift of more than \$150,000, the three of them secured state-of-the-art imaging technology for Valley View, as well as the processing power to handle it.

Together, the generosity of our community drives innovation and enhances patient care at Valley View.

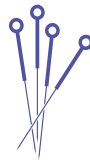
